Fiscal year 2020 has been a wild ride that few, if any of us, have ever experienced before. The pandemic and the associated stay at home order and social distancing guidelines coupled with economic uncertainty have made it difficult for traditional fund-raising for the CCH Foundation. All the major Hospital events held in the spring and summer were cancelled and the Foundation Board met just twice during the year (instead of quarterly). Hidden Treasures, the Hospital's Auxiliary run gift shop, closed the second week of March and the volunteer program was placed on hold. Neither will resume until the spread of COVID-19 is under control.

You, however, have made a difference to the patients and families we serve each and every day. Your philanthropy has made a significant positive impact on the Hospital and the people we serve. 

COVID-19's arrival in late February created many challenges for the Hospital and Foundation. However, the stimulus funding that was approved by Congress to supplement healthcare's response provided opportunities that helped the Hospital overcome the many challenges presented by the pandemic and to enhance our telemedicine services.

Planned Giving

There are as many ways to support Clarke County Hospital as there are needs to be supported. Bequests - through a will or other form of estate plan, a deferred gift can provide a gift beyond what current means allow

Beneficiary - designating the Foundation as a beneficiary of a retirement plan, life insurance, an annuity, or a will is a way to allow your gift to extend beyond your lifetime

Charitable Trust - various trusts can be used to provide value to the donor and provide a gift to the Foundation

Property - this can include a gift of securities, insurance policies, and real estate. In a rural community, there is the potential to include the Hospital Foundation as the beneficiary of farmland. Also, stocks, bonds and mutual funds can be donated, often with positive consequences for your estate taxes.
